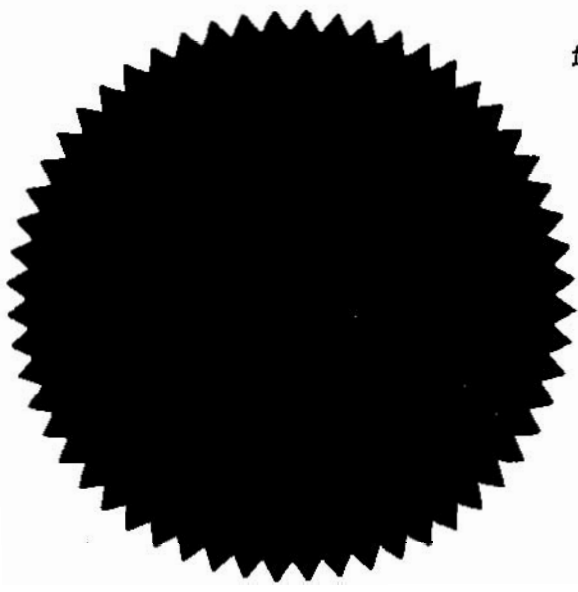
You are hereby summoned to appear before the Judge in
